- Prepare the shoot locations, select and set up the objects and collaborators, the lighting, the photographic conditions, and take the photographs based on these;
- Take event and report photographs, portraits, group pictures, photo-illustrations, reproductions, document reproductions, object photographs, still-life photographs, city and landscapes, glamour and nude photographs, advertising photos and photo-essays;
- Perform a public photography service;
- Take artistic photographs after performing technique and material experiments;
- Select photographic material, edit it, present it with text, captions and take care of its archiving;
